# We Need Your Partnership To Grow

#### NEW BAC BOARD MEMBERS AND OFFICERS

To meet our hopes and goals, we will need the partnership of a strong Board and membership. We are seeking nominations for both Board and Committee Chairs.

The current Board/Committee Chairs will vet any nominations and provide a slate of potential Board members to be voted in by the membership prior to the January, Annual General Meeting. The vote will be held online, so the entire membership will have an opportunity to have their voice heard.

# We need your support. Please nominate anyone you feel would be a valuable asset to the Board. You may also self-nominate. Participation is critical. If we don't have an active Board, our organization will be a good idea that unfortunately just withers away.

#### What We Need: The Addition of 5 – 7 New Board Members

New Board members may be from our current BAC membership or recommended leaders in our community. They do not need to be artists, in fact we need Board members who aren't – think lawyers, CPAs, business owners – people that want to be part of expanding the arts and tourism in Blaine.

#### **Board Commitment:**

- One 30 60-minute Exec/Board meeting per month via Zoom. Must attend a minimum of 8 per year. Any additional absences must have prior approval from the Board.
- Current BAC membership (if not an active member, they will need to join).
- Attend a minimum of 7 General Meetings per year.
- Support a BAC Committee.

The newly adopted BAC bylaws call for a 3-year Board commitment. Board members may resign early if needed. If that occurs, and the Board member holds an Officer position, the Board will vote on their replacement and notify the membership of the change.

<u>Board Officers:</u> In January, the newly elected Board will select from within its ranks, Officers to fill the remaining open positions. The membership will be notified of those appointments. If you are interested in being on the Board and holding one of these positions, here are the estimates of time involved and required duties.

#### Secretary: Approx 3 hours per month

Takes minutes at the Exec/Board & General meetings. The Zoom meeting will be transcribed for ease of minutes.

Keeps the Corporate Binder updated each month with minutes and finance reports.

# Treasurer: Approx 2 hours per month (except during the WAVE, which could be 10 – 15 hours during the event month).

Reconciles the monthly bank statement.

Provides financial reports for monthly meeting of the Exec/Board.

During events: Pays for rentals, supplies, and reimburses committee for expenses, etc.

Compiles and submits the BTAC grant paperwork for reimbursement.

#### Vice President: Approx 5 hours per month

In the absence of the President, the VP will preside over Exec/Board or General Meetings, etc. Oversee the Committees – The Committee Chairs will advise the VP of their progress and notify of any issues that the Board needs to manage/provide input.

Attend Committee meetings if they desire or are requested by the Committee.

# We Need Your Partnership To Grow - Continued

#### Committee Chairs Needed & Their Responsibilities:

#### Artist Relations Chair: Need 2 members

Set artists for art festivals/studio tours, and any other events that will be host our local artists. Build relationships with area non-member artists and invite them to join us.

#### **Community Outreach Chair: Need 3 members**

Chair information-only events, i.e. Holiday Bazaar, 4th of July Parade, & Oyster Fest. Work with schools to promote art, art camps, and recommend student scholarships, etc.

#### Events Chair: Need 3 - 7 members, depending on the event size

Chair the WAVE Opening Night & Art Festival, and the Sea to See Art Show.

#### Membership Chair: Need 2 - 3 members

Manage the membership list and communicate with members regarding their membership status. Membership correspondence and membership/sponsorship enrollment.

General meeting: name tag management, greeting, evening enrollments, and keeper of tags.
